Pursuant to 35 U.S.C. §§ 141 and 142 and 37 C.F.R. §§ 90.2 and 90.3, Patent Owner, Finjan, Inc., hereby provides notice that it appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision of the Patent Trial and Appeal Board ("the Board") entered March 15, 2017 (Paper 58) and from all underlying orders, decisions, rulings, and opinions regarding U.S. Patent 8,677,494 ("the '494 patent") at issue in *inter partes* review IPR2015-01892.

The issues on appeal, pursuant to 37 C.F.R. § 90.2(a)(3)(ii) include, but are not limited to, the Board's construction of the terms "list of suspicious computer operations" and "storing the Downloadable security profile data in a database"; the Board's determination that Petitioner showed by a preponderance of the evidence that claims 1, 2, and 6 of the '494 Patent are unpatentable under 35 U.S.C. § 103 over Morton Swimmer et al., *Dynamic Detection and Classification of Computer Viruses Using General Behaviour Patterns*, Virus Bull. Conf. 75 (Sept. 1995) (Ex. 1005) ("Swimmer"); the Board's interpretation of Swimmer; the Board's determination that Swimmer was publicly available; any finding or determination supporting or related to those issues; as well as other issues decided adversely to Finjan in any orders, decisions, rulings, and opinions.
