COMPLAINT

Plaintiff Texas Patent Imaging LLC ("Plaintiff" or "TPI") files this original Complaint against Canon Inc., Canon U.S.A., Inc. and Canon Solutions America, Inc. ("Defendants" or "Canon") for infringement of United States Patent No. 8,437,797 (hereinafter "the '797 Patent").

PARTIES AND JURISDICTION

- This is an action for patent infringement under Title 35 of the United States
 Code. Plaintiff is seeking injunctive relief as well as damages.
- 2. Jurisdiction is proper in this Court pursuant to 28 U.S.C. §§ 1331 (Federal Question) and 1338(a) (Patents) because this is a civil action for patent infringement arising under the United States patent statutes.
- 3. Plaintiff is a Texas limited liability company with its principal office located at 1400 Preston Rd., Suite 400, Plano, TX 75093.
- 4. On information and belief, defendant Canon Inc., also known as Canon Kabushiki Kaisha, is a corporation organized under the laws of Japan having a principal place

of business at 30-2, Shimomaruko 3-chome, Ohta-ku, Tokyo 146-8501, Japan.

- 5. On information and belief, Canon U.S.A., Inc. is a wholly-owned and controlled subsidiary of Canon Inc. and is a corporation organized and existing under the laws of the State of New York, with its principal place of business at One Canon Plaza, Lake Success, New York, 11042-1113.
- 6. On information and belief, Canon Solutions America, Inc. is a wholly-owned and controlled subsidiary of Canon U.S.A., Inc. and is a corporation organized and existing under the laws of the State of New York, with its principal place of business at One Canon Plaza, Lake Success, New York, 11042-1113.
- 7. On information and belief, Canon Inc., Canon U.S.A., Inc., and Canon Solutions America, Inc. have been and are acting individually, collectively, and jointly or in concert with regard to all Canon activities referenced and alleged in this Complaint.
- 8. On information and belief, this Court has personal jurisdiction over Defendants because Defendants have committed, and continues to commit, acts of infringement in the state of Texas, have conducted business in the state of Texas, and/or have engaged in continuous and systematic activities in the state of Texas.
- 9. On information and belief, Defendants' instrumentalities that are alleged herein to infringe were and continue to be used, imported, offered for sale, and/or sold in the Eastern District of Texas.

VENUE

10. Venue is proper in the Eastern District of Texas pursuant to 28 U.S.C. §§ 1391(c) and 1400(b) because Defendants are deemed to reside in this district. In addition, and in the alternative, Defendants have committed acts of infringement in this District.

COUNT I (INFRINGEMENT OF UNITED STATES PATENT NO 8,437,797)

- 11. Plaintiff incorporates paragraphs 1-10 herein by reference.
- 12. This cause of action arises under the patent laws of the United States and, in particular, under 35 U.S.C. §§ 271, et seq.
- 13. Plaintiff is the owner by assignment of the '797 patent with sole rights to enforce the '797 patent and sue infringers.
- 14. A copy of the '797 Patent, titled "Wireless Image Distribution System and Method," is attached hereto as Exhibit A.
- 15. The '797 Patent is valid, enforceable, and was duly issued in full compliance with Title 35 of the United States Code.
- 16. Upon information and belief, Defendants have infringed and continue to infringe one or more claims, including at least claim 6, of the '797 patent by making, using, importing, selling, and/or offering for sale cameras covered by one or more claims of the '797 patent.
- 17. On information and belief, Defendants sell, offer to sell, and/or use cameras, including, without limitation, the Canon EOS 6D, which infringes at least Claim 6 of the '797 Patent.
- 18. The Canon EOS 6D is a portable, or mobile, device, which may be used for capturing images.
- 19. The Canon EOS 6D is Wi-Fi equipped and has a wireless transmitter. On information and belief, the Canon EOS 6D also includes a wireless receiver.
 - 20. The Canon EOS 6D includes a processor such as, for example, the DIGIC 5+

Image Processor. The Canon EOS 6D is advertised as capable of transmitting images to other systems and devices. On information and belief, the Canon EOS 6D's processor is operably connected to camera's Wi-Fi system, such that images can be sent and received via the Wi-Fi system.

- 21. On information and belief, the Canon EOS 6D's processor can receive and process images captured by the camera. The processor can cause images captured by the camera to be stored and available for access by a user.
- 22. On information and belief, at least when working with the Canon Camera Connect application linked to the camera, the Canon EOS 6D's processor can filter images, such as its stored images, according to a transfer criterion. The transfer criterion, according to one example, may be a user's selection of images stored on the camera, the selected images being intended for transfer from the camera to a second mobile device, such as, for example, an Android device.
- 23. On information and belief, the Canon EOS 6D receives the transfer criterion (e.g., the user's selection of images) from the second mobile device via the camera's Wi-Fi receiver.
- 24. On information and belief, the processor can cause the selected (i.e., filtered) images to be transmitted to a second mobile device, such as, for example, an Android device.
- 25. Defendants' actions complained of herein will continue unless Defendants are enjoined by this court.
- 26. Defendants' actions complained of herein are causing irreparable harm and monetary damage to Plaintiff and will continue to do so unless and until Defendants are enjoined and restrained by this Court.

27. Plaintiff is in compliance with 35 U.S.C. § 287.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff asks the Court to:

- (a) Enter judgment for Plaintiff on this Complaint on all causes of action asserted herein;
- (b) Enter an Order enjoining Defendants, their agents, officers, servants, employees, attorneys, and all persons in active concert or participation with Defendants who receive notice of the order from further infringement of United States Patent No. 8,437,797 (or, in the alternative, awarding Plaintiff a running royalty from the time of judgment going forward);
- (c) Award Plaintiff damages resulting from Defendants' infringement in accordance with 35 U.S.C. § 284;
 - (d) Award Plaintiff pre-judgment and post-judgment interest and costs; and
- (e) Award Plaintiff such further relief to which the Court finds Plaintiff entitled under law or equity.
