**OTSUKA'S NOTICE OF APPEAL**

Notice is hereby given that Otsuka Pharmaceutical Co., Ltd. ("Otsuka") appeals to the United States Court of Appeals for the Federal Circuit from the Joint Stipulation and Order for Entry of Partial Rule 56 Summary Judgment of Noninfringement concerning U.S. Patent No. 8,759,350 ("the '350 patent") (D.I. 206) issued by the United States District Court for the District of New Jersey (Camden) on January 19, 2016, and certified as final by the Court pursuant to Fed. R. Civ. P. 54(b) on April 12, 2016 (D.I. 241, 240). The Joint Stipulation and Order for Entry of Partial Rule 56 Summary Judgment of Noninfringement was based on the District Court's construction of the claim terms "a/the pharmaceutical composition" and "in

combination with,” as they appear in the claims of the ’350 patent. (*See, e.g.*, D.I. 240 at 3.) Otsuka further appeals all findings of fact and conclusions of law, opinions, orders, and rulings insofar as they relate to those claim terms or to any other issue addressed in the Joint Stipulation and Order for Entry of Partial Rule 56 Summary Judgment of Noninfringement, including, inter alia, the District Court’s Markman Order (D.I. 184) and accompanying Opinion (D.I. 183) and its Order denying Otsuka’s Motion for Temporary Restraining Order (D.I. 106) and accompanying Opinion (D.I. 104, 105).
