Pursuant to 28 U.S.C. § 1295(a)(1) and Rule 3(a)(1) of the Federal Rules of Appellate Procedure, notice is hereby given that Plaintiffs Steven L. Zimmers and Daniel W. Davis ("Plaintiffs") appeal to the *United States Court of Appeals for the Federal Circuit* from the Final Judgment (Dkt. 42) and the Court's Opinion and Order (Dkt. 41), entered on August 2, 2016, which granted judgment on the pleadings in favor of Defendants that the claims of U.S. Patent No. 9,015,256 and U.S. Patent No. RE44,535 are invalid under 35 U.S.C. § 101, and denied Plaintiffs' cross-motion for judgment on the pleadings regarding the same issue.
