PLAINTIFFS' NOTICE OF APPEAL

Notice is hereby given that Plaintiffs EMC Corp., EMC International Co., and EMC Information Systems International (collectively, "EMC") appeal to the United States Court of Appeals for the Federal Circuit from the denial of a permanent injunction in the Memorandum and Order of this Court entered on September 1, 2016 (D.I. 534) ("the Order"), and from any and all other orders, opinions, rulings, and findings that merge therein or are pertinent or ancillary to the foregoing. Because the Order denied EMC's motion for a permanent injunction, an interlocutory appeal is permitted pursuant to 28 U.S.C. § 1292(a)(1).

Payment of the required fee of \$505 is provided with this Notice of Appeal. This fee includes the \$500 fee for docketing a case on appeal as required by 28 U.S.C. § 1913 and Fed. Cir. R. 52(a)(2) and the \$5 fee for filing a notice of appeal as required by 28 U.S.C. § 1917.
