**PLAINTIFFS INTELLECTUAL VENTURES I LLC AND
INTELLECTUAL VENTURES II LLC’S NOTICE OF APPEAL**

Plaintiffs Intellectual Ventures I LLC and Intellectual Ventures II LLC (together, “Intellectual Ventures”) respectfully submit this notice of its appeal to the United States Court of Appeals for the Federal Circuit. Plaintiffs appeal from the district court’s February 13, 2017 Memorandum Opinion (Sealed D.I. 335) and February 16, 2017 Final Judgment (D.I. 340) finalizing the Judgment of Non-Infringement of U.S. Patent No. 6,598,131 and granting Defendants’ Motion for Summary Judgment of Patent Invalidity Under 35 U.S.C. § 101 (D.I. 276) and Defendants’ Motion for Summary Judgment of Non-Infringement of U.S. Patent No. 5,537,533 (D.I. 280), and from all related orders, rulings, findings, decisions, stipulations, or conclusions entered in this action that were adverse to Intellectual Ventures, including the Court’s Memorandum Opinion and Order concerning claim construction (D.I. 214; D.I. 215) and the Court’s June 30, 2016 oral ruling on Defendants’ Motion to Strike IV’s Amended Infringement Contentions (D.I. 247).

This notice of appeal is timely under Federal Rule of Appellate Procedure 4(a)(1)(A) because it is “filed with the district clerk within 30 days after entry of the judgment or order appealed from.”

As part of this notice of appeal, Intellectual Ventures submits the required filing fee of \$505 and respectfully requests the district clerk to prepare the record on appeal pursuant to Federal Rule of Appellate Procedure 10(a). Intellectual Ventures will order from the reporter a transcript of such part of the proceedings not already on file as the appellant considers necessary, as required by Federal Rule of Appellate Procedure 10(b)(1)(A).
