**NOTICE OF CROSS-APPEAL**

On March 20, 2017, Plaintiffs filed a Notice of Appeal to the United States Court of Appeals for the Federal Circuit in this civil action (D.I. 342, docketed as Appeal No. 17-1814), appealing, *inter alia*, from the district court's entry of Final Judgment on February 16, 2017 (D.I. 340) that Defendants Symantec Corporation and Veritas Technologies LLC did not infringe the asserted claims of United States Patent No. 5,537,533 and that those claims were invalid, and from the district court's determination (and the related stipulated judgment, entered on October 25, 2016 (D.I. 288)) that Symantec and Veritas did not infringe the asserted claims of United States Patent No. 6,598,131.

Notice is hereby given that Defendants Symantec Corporation and Veritas Technologies LLC appeal to the United States Court of Appeals for the Federal Circuit from the Final Judgment entered by the District Court on February 16, 2017 (D.I. 340) and the Stipulation And Non-Final Judgment Of Non-Infringement Of U.S. Patent No 6,598,131 entered by the District Court on October 25, 2016 (D.I. 288) and made final on February 16, 2017 by the Final Judgment, along with all adverse findings, rulings, conclusions, determinations, opinions, and

orders leading thereto or merged therein, including, but not limited to, the claim construction order entered by the District Court on March 10, 2016 (D.I. 215).
