## COMPLAINT

Plaintiffs Bristol-Myers Squibb Company ("BMS") and Pfizer Inc. ("Pfizer") (BMS and Pfizer, collectively, "Plaintiffs"), by their attorneys, hereby allege as follows:

## NATURE OF THE ACTION

1. This is an action for patent infringement arising under the patent laws of the United States, Title 35, United States Code, against Defendant Unichem Laboratories, Ltd. ("Unichem"). This action relates to Abbreviated New Drug Application ("ANDA") No. 210108 filed by Unichem with the U.S. Food and Drug Administration ("FDA").

2. In ANDA No. 210108, Unichem seeks approval to market 2.5 mg and 5 mg tablets of apixaban, generic versions of Plaintiffs' Eliquis<sup>®</sup> drug product (the "Unichem ANDA product"), prior to expiration of U.S. Patent No. 9,326,945 (the "945 patent" or "patent-in-suit").

## PARTIES

3. BMS is a corporation organized and existing under the laws of Delaware, having a place of business at Route 206 and Province Line Road, Princeton, New Jersey 08540.

4. Pfizer is a corporation organized and existing under the laws of Delaware, having its principal place of business at 235 East 42nd Street, New York, New York 10017.

5. Plaintiffs are engaged in the business of creating, developing, and bringing to market revolutionary pharmaceutical products to help patients prevail against serious diseases, including treatments for thromboembolic disorders. Plaintiffs sell Eliquis<sup>®</sup> in this judicial district and throughout the United States.

6. Upon information and belief, Unichem is a corporation organized and existing under the laws of India, having its principal place of business at Unichem Bhavan, Prabhat Estate, Off S V Road, Jogeshwari (West), Mumbai 400102 Maharashtra, India.

#### JURISDICTION AND VENUE

7. This action arises under the patent laws of the United States, 35 U.S.C. §§ 100, *et seq.*, and this Court has jurisdiction over the subject matter of this action under 28 U.S.C. §§ 1331, 1338(a), 2201, and 2202.

8. Venue is proper in this Court under 28 U.S.C. §§ 1391 and/or 1400(b), and this Court has personal jurisdiction over Unichem. Unichem through its counsel, by e-mails exchanged with counsel for Plaintiffs on March 20, 2017, March 22, 2017, and April 5, 2017 agreed that it does not contest jurisdiction or venue in this Court in this matter.

#### PATENT-IN-SUIT

9. On May 3, 2016, the U.S. Patent and Trademark Office duly and legally issued the '945 patent, titled "Apixaban Formulations." A true and correct copy of the '945 patent is attached hereto as Exhibit A. The claims of the '945 patent are valid, enforceable, and not expired. Plaintiffs are the joint owners of the '945 patent and have the right to enforce it.

10. BMS is the holder of New Drug Application ("NDA") No. 202155, by which the FDA granted approval for the marketing and sale of 2.5 mg and 5 mg strength apixaban tablets.

Plaintiffs market apixaban tablets in the United States, under the trade name "Eliquis<sup>®</sup>." The FDA's official publication of approved drugs (the "Orange Book") includes Eliquis<sup>®</sup> together with the patent-in-suit. Eliquis<sup>®</sup> is a factor Xa inhibitor indicated: (1) to reduce the risk of stroke and systemic embolism in patients with nonvalvular atrial fibrillation; (2) for the prophylaxis of deep vein thrombosis ("DVT"), which may lead to pulmonary embolism ("PE"), in patients who have undergone hip or knee replacement surgery; and (3) for the treatment of DVT and PE, and for the reduction in the risk of recurrent DVT and PE following initial therapy. A copy of the complete prescribing information for Eliquis<sup>®</sup> approved in NDA No. 202155 is attached as Exhibit B.

### **INFRINGEMENT BY UNICHEM**

11. By letter sent by Federal Express on February 24, 2017, Unichem notified Plaintiffs that Unichem had submitted ANDA No. 210108 to the FDA under Section 505(j) of the Federal Food, Drug, and Cosmetic Act (21 U.S.C. § 355(j)) ("the Eliquis Notice Letter"). Plaintiffs received the Eliquis Notice Letter no earlier than February 27, 2017.

12. The Eliquis Notice Letter states that Unichem seeks approval from the FDA to engage in the commercial manufacture, use, and sale of the Unichem ANDA product before the expiration of the patent-in-suit. Upon information and belief, Unichem intends to – directly or indirectly – engage in the commercial manufacture, use, and sale of the Unichem ANDA product promptly upon receiving FDA approval to do so.

13. By filing ANDA No. 210108, Unichem has necessarily represented to the FDA that the Unichem ANDA product has the same active ingredient as Eliquis<sup>®</sup>, has the same dosage form and strength as Eliquis<sup>®</sup>, and is bioequivalent to Eliquis<sup>®</sup>.

14. Upon information and belief, Unichem is seeking approval to market the Unichem ANDA product for the same approved indications as Eliquis<sup>®</sup>.

15. In the Eliquis Notice Letter, Unichem states that its ANDA contains a certification pursuant to 21 U.S.C. § 355(j)(2)(A)(vii)(IV) asserting that the patent-in-suit is invalid, unenforceable, and/or will not be infringed by the commercial manufacture, use, and sale of the Unichem ANDA product.

16. In the Eliquis Notice Letter, Unichem offered confidential access to portions of its ANDA No. 210108 on terms and conditions set forth in the Eliquis Notice Letter ("the Unichem Offer"). Unichem requested that Plaintiffs accept the Unichem Offer before receiving access to Unichem's ANDA No. 210108. The Unichem Offer contained unreasonable restrictions well beyond those that would apply under a protective order on who could view the ANDA. For example, the Unichem Offer contained a broad patent prosecution bar, which, among other things, does not have a carve-out for inter-partes reviews or other adversarial proceedings, and a broad bar on any work related to actions before the FDA. The Unichem Offer unreasonably restricted the ability of counsel to seek the opinions of outside experts without written permission from Unichem's designated counsel; and Unichem had broad authority to reject any request by Plaintiffs to seek outside expert access to the Unichem ANDA. The Unichem Offer unreasonably restricted the ability of counsel to discuss any relevant findings with Plaintiffs. The restrictions Unichem has placed on access to ANDA No. 210108 contravene 21 U.S.C. § 355(j)(5)(C)(i)(III), which states that an offer of confidential access "shall contain such restrictions as to persons entitled to access, and on the use and disposition of any information accessed, as would apply had a protective order been entered for the purpose of protecting trade secrets and other confidential business information" (emphasis added).

17. This Complaint is being filed before the expiration of forty-five days from the date Plaintiffs received the Eliquis Notice Letter.

#### <u>COUNT I</u>

## (INFRINGEMENT OF THE '945 PATENT)

18. Each of the preceding paragraphs 1 to 17 is incorporated as if fully set forth herein. 19. Unichem's submission of ANDA No. 210108 to obtain approval to engage in the commercial manufacture, use, offer to sell, or sale of the Unichem ANDA product prior to the expiration of the '945 patent constituted a technical act of infringement of at least one of the claims of the '945 patent, either literally or under the doctrine of equivalents, including but not limited to claims 1, 9-12, 20-23, 25, 27, 29, 31, 33, 35, and 37, under 35 U.S.C. § 271(e)(2)(A).

20. Unichem's commercial manufacture, use, offer to sell, sale, or importation of the Unichem ANDA product prior to the expiration of the '945 patent, and its inducement of and/or contribution to such conduct, would further infringe at least one of the claims of the '945 patent, either literally or under the doctrine of equivalents, including but not limited to claims 1, 9-12, 20-23, 25, 27, 29, 31, 33, 35, and 37, under 35 U.S.C. §§ 271(a), (b) and/or (c).

21. Upon FDA approval of Unichem's ANDA No. 210108, Unichem will infringe one or more claims of the '945 patent, either literally or under the doctrine of equivalents, including but not limited to claims 1, 9-12, 20-23, 25, 27, 29, 31, 33, 35, and 37, by making, using, offering to sell, and selling the Unichem ANDA product in the United States and/or importing said product into the United States, or by actively inducing and contributing to infringement of the '945 patent by others, under 35 U.S.C. § 271(a)-(c), unless enjoined by the Court.

22. If Unichem's marketing and sale of the Unichem ANDA product prior to expiration of the '945 patent and all other relevant exclusivities are not enjoined, Plaintiffs will suffer substantial and irreparable harm for which there is no remedy at law.

### PRAYER FOR RELIEF

WHEREFORE, Plaintiffs pray that this Court grant the following relief:

1. A judgment that the claims of the patent-in-suit are not invalid, are not unenforceable, and are infringed by Unichem's submission of ANDA No. 210108, either literally or under the doctrine of equivalents, and that Unichem's making, using, offering to sell, or selling in the United States, or importing into the United States the Unichem ANDA product will infringe the claims of the patent-in-suit, either literally or under the doctrine of equivalents.

2. An order pursuant to 35 U.S.C. § 271(e)(4)(A) providing that the effective date of any approval of ANDA No. 210108 shall be a date which is not earlier than the latest expiration date of the patent-in-suit, including any extensions and/or additional periods of exclusivity to which Plaintiffs are or become entitled.

3. An order permanently enjoining Unichem, its affiliates, subsidiaries, and each of its officers, agents, servants and employees and those acting in privity or concert with them, from making, using, offering to sell, or selling in the United States, or importing into the United States the Unichem ANDA product until after the latest expiration date of the patent-in-suit, including any extensions and/or additional periods of exclusivity to which Plaintiffs are or become entitled.

4. Damages or other monetary relief, including costs, fees, pre and post-judgment interest, to Plaintiffs if Unichem engages in commercial manufacture, use, offers to sell, sale, or importation in or into the United States of the Unichem ANDA product prior to the latest expiration date of the patent-in-suit, including any extensions and/or additional periods of exclusivity to which Plaintiffs are or become entitled.

5. Such further and other relief as this Court deems proper and just, including any appropriate relief under 35 U.S.C. § 285.
