- 4. Upon information and belief, Defendant is a corporation organized under the laws of the State of California and has its principal place of business at 3420 Vinton Avenue, Apartment 4, Los Angeles, California 90034.
- 5. Upon information and belief, Defendant resides in this judicial district, does business in this judicial district, and a substantial part of the events giving rise to the claims in this case occurred in this judicial district.

A copy of the '270 patent is attached hereto as **Exhibit 3**.
 - 16. Defendant has notice of BottleKeeper's rights in the '270 patent.
- 17. Defendant has engaged, and continues to engage, in the business of manufacturing, using, importing, offering for sale, and/or selling bottle enclosures embodying one or more of the patented inventions disclosed and claimed in the '270 patent ("the '270 Patent Infringing Products"). The '270 Patent Infringing Products include, without limitation, Defendant's "Beer Bottle Cooler." Copies of relevant pages from Defendant's Internet website (www.glaciio.com) illustrating its "Beer Bottle Cooler" are attached hereto as **Exhibit 2**.
- 18. - 19. Defendant's continuing infringement has inflicted and, unless restrained by this Court, will continue to inflict great and irreparable harm upon BottleKeeper. BottleKeeper has no adequate remedy at law, and is entitled to

preliminary and permanent injunctions enjoining Defendant from engaging in further acts of infringement.

- 20. As a direct and proximate result of the foregoing acts of Defendant, BottleKeeper has suffered, and is entitled to, monetary damages in an amount not yet determined. BottleKeeper is also entitled to its costs of suit and interest.
- 21. Upon information and belief, Defendant's acts were in conscious and willful disregard for BottleKeeper's rights, and the resulting damage to BottleKeeper is such as to warrant the trebling of damages to provide just compensation.

PRAYER FOR RELIEF

WHEREFORE, BottleKeeper respectfully demands judgment:

- 1. That Defendant, its officers, directors, agents, servants, employees, attorneys, confederates, and all persons and/or entities acting for, with, by, through, or in concert with them, or any of them, be enjoined preliminarily and permanently from infringing the '527 patent and the '270 patent;
- 2. That Defendant be required to deliver up to the Court any and all products in its possession, custody, and/or control that infringe the '527 patent and/or the '270 patent;
- 3. That Defendant be required to prepare and deliver to the Court a complete list of entities from whom Defendant purchased, and to whom it distributed and/or sold, products that infringe the '527 patent and/or the '270 patent;
- 4. That Defendant be required to deliver to the Court any and all documents reflecting or relating to the manufacture, purchase, sale, and/or distribution of any products that infringe the '527 patent and/or the '270 patent;
- 5. That Defendant, within thirty (30) days after service of judgment with notice of entry thereof upon it, be required to file with the Court and serve upon BottleKeeper's attorneys a written report, under oath, setting forth in detail the manner in which Defendant has complied with paragraphs 1-4, above;

1	6.	That BottleKeeper be awarded compensatory damages for infringement

4	7.	That BottleKeeper be awarded costs of this suit;
